Communications Committee:

President:

Gilbert pointed out that if they continue to make it difficult to present at their conference we need to consider not participating in the future. Gaudiello suggested she write an article for the Town & City magazine on our presentation if we are not accepted.
- The Open Houses are coming up and Knight would like to appoint a coordinator for future Open Houses. We are doing the initial events and a coordinator would make sure the local libraries keep the open houses going. There are 11 co-ops.
- Solon said that we should send out a suggestion that local library budgets be increased to cover our dues increase. She will write an article for the newsletter.

State Library:

- Works of Edgar Allen Poe will be read as part of the National Endowment of the Arts program "The Big Read NH".
- York will be doing a presentation in Peterborough Oct. 2 and in Conway Oct. 30.
