## NHLTA MEMBERSHIP

The mission of the NH Library Trustees Association is "to assist Trustees to be knowledgeable and effective in order to serve, improve and promote New Hampshire public libraries." We accomplish this mission by providing an array of services to our members.

Founded in 1957, the New Hampshire Library Trustees Association is an independent nonprofit organization registered with the NH Division of Charitable Trusts. The NHLTA has no affiliation with the state library, nor does it receive any state or federal funding. The activities of the volunteer Board are funded from membership dues, registration fees, and grants.

## **GOALS AND OBJECTIVES**

The NHLTA's goals and objectives are to develop a more effective body of public library trustees by providing educational opportunities to assist in understanding the responsibilities and duties of the position; to offer a forum for the exchange of information and ideas; provide current information about library developments; and to advocate for and promote public library services in New Hampshire.

**Education:** Our signature event is our annual conference where we provide speakers and workshops on a variety of timely subjects. We also offer several Trustee Orientation sessions each year, targeted to newly elected trustees, where we review trustee responsibilities, as well as NH State Laws governing libraries, budgeting, personnel and more. And, we offer additional workshops on specific topics relating to trustee duties and responsibilities, such as Writing Polices, Hiring and Firing, Working with the Budget and more.

**Information Sharing and Assistance:** Our quarterly newsletter, mailed to all members, provides a wealth of information on topics of interest to trustees. Regional Gatherings around the state provide trustee networking and sharing of knowledge and news.
